Sealed Bids addressed to Mr. Steve Bearden, Port Director, at the office of the Port Isabel – San Benito Navigation District, 250 Industrial Drive, Port Isabel, TX 78578, will be received until Thursday, October 27, 2022, 2:00 PM, local time, for furnishing all materials, supplies, labor and equipment necessary for the construction of the **PORT ISABEL – SAN BENITO NAVIGATION DISTRICT, 2022 PORT ROAD IMPROVEMENTS**, in accordance with the plans and specifications on file at the Port Isabel San Benito Navigation District office. At the time stated, Bids received will be publicly opened and read. Major items of work consist of installing 3 inch to 5 inch HMAC Overly Pavement, RCP drainage pipes and drainage inlets.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with additional alternate bid items as indicated in the Bid Form.
