A Pre-Bid Conference will be held at 10:00 a.m. January 5th, 2023, at Santa Rosa City Hall located at 411 S. 6th St., Santa Rosa, Texas, 78593. Attendance is recommended for all prospective bidders.

Attention is called to the fact that not less than, the federally determined prevailing (Davis-Bacon and Related Acts) wage rate as issued by the United States Department of Labor and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, age or national origin.
