## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.073678 per \$100 valuation has been proposed by the governing body of EMERGENCY SERVICE DISTRICT #1.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for EMERGENCY SERVICE DISTRICT #1 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that EMERGENCY SERVICE DISTRICT #1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that EMERGENCY SERVICE DISTRICT #1 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 30, 2023 AT 1:30PM AT EMERGENCY SERVICES DISTRICT NO. 1.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, EMERGENCY SERVICE DISTRICT #1 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Cameron County Emergency Services District No. 1 of EMERGENCY SERVICE DISTRICT #1 at their offices or by attending the public hearing mentioned above.
