## **BUS 77 from FM 507 to FM 510**

#### **Project Description and Purpose**

The Texas Department of Transportation (TxDOT) Pharr District will host a public meeting to present the proposed reconstruction and widening for BUS 77 in Cameron County. The proposed BUS 77 project would extend approximately 7.05 miles from FM 507 in Harlingen to FM 510 in San Benito. The proposed project consists of roadway reconstruction and widening to construct raised medians, add lane capacity, accommodate bicycles and pedestrians, and improve bridges. The purpose of these public meetings is to present the proposed design and gather input. You are invited to view project maps, exhibits, and visit with TxDOT staff and the project team, ask questions, and share comments on the proposed improvements.
