## **MAKE ARRANGEMENTS TO PAY YOUR PROPERTY TAXES NOW!**

## **OFFICES COUNTYWIDE TO BETTER SERVE YOU!**

**DROP OFF BOXES 24/7:** Tax payments may be dropped-off at the Drop-Off-Boxes located at the Brownsville Main Office (next to the motor bank on Levee St.), Port Isabel Branch Office, San Benito Motor Bank, Harlingen Motor Bank, and Los Fresnos Branch Office located at the address to the left. Payments dropped off after business hours and next day before 8:00 a.m. will be processed with the previous day's date. All payments dropped-off after 8:00 a.m. will be processed the next business day.

**INTERNET PAYMENTS 24/7:** Account information may be viewed and online payments can be made by going to [www.cameroncountytexas.gov/tac](http://www.cameroncountytexas.gov/tac), a service fee of \$1 will be charged to pay a property tax bill using an eCHECK in the amount of \$5,000 or less. Online check payments over \$5,000.01 will be charged \$3, and credit and debit cards will incur a 3% convenience fee online and in person.

**PAYMENTS MAY BE MADE AT LONE STAR NATIONAL BANK LOCATIONS IN CAMERON COUNTY.** Current Year Property Taxes can now be paid at Lone Star National Bank Locations in Cameron County. A copy of your 2023 consolidated tax bill must be presented in order to make a payment.
