By Order of the Court, you are cited and required to appear before the judge presiding in Departmen124 of the above-entitled court, or such other department as may be assigned, at the courthouse located at 3341 Power Inn Road, Sacramento, CA 95826 on 1/16/24, at the hour of 2:30 pm of that day, then and there to show cause, if any you have, why the Petition of Jesse Alfonso Carrasco and Jalissa Marie Carrasco to have your parental rights terminated as to the minor, Madden Miguel Carrasco, a male minor child born on June 9, 2014 to Jesse Alfonso Carrasco and Angela Teresa Macias, should not be granted, in accordance with the Petition to Terminate Parental Rights of Mother, filed herein, a copy of which Petition is attached for further particulars, served herewith, and incorporated by this reference.

At the time of the hearing you must show cause why the Petition to Terminate Parental Rights of Mother should not be granted without your consent in the above entitled proceeding on the ground that you have abandoned that child. The above referenced Petition to Terminate Parental Rights of Mother alleges that as of July 2019, you willfully failed to communicate with and pay for the care, support and education of the above-named child, although able to do so.

At the beginning of the proceeding counsel shall be appointed for you pursuant to Family Code§ 7860. The public defender or private counsel may be appointed as counsel. The same counsel shall not be appointed to represent both the child and you. Pursuant to Family Code § 7861 the Court shall consider whether the interests of the child require the appointment of counsel. If the court finds that the interests of the child require representation counsel, the court shall appoint counsel to represent the child, whether or not the child is able to afford counsel. Pursuant to Family Code § 7862 if a parent appears without counsel and is unable to afford counsel, the court shall appoint counsel for the parent unless that representation is knowingly and intelligently waived. Pursuant to Family Code § 7863 private counsel appointed shall receive a reasonable sum for compensation and expenses, the amount of which shall be determined by the court. The amount so determined shall be paid by the real parties in interest, in proportions the court deems just. However, if the court finds that any of the real parties in interest are unable to afford counsel, the amount shall be paid out of the general fund of the county. The Court may continue the proceeding for not to exceed 30 days as necessary to appoint counsel.

For failure to attend, you may be deemed guilty of contempt of court.

The Petition filed in this proceeding is for the purpose of freeing the subject child from your parental control and for failure to attend, your parental rights to the minor may be terminated without further notice to you.
