The no-new-revenue tax rate is the tax rate for the 2024 tax year will raise the same amount of property tax revenue for the City of La feria from the same properties in both the 2023 tax year and the 2024 tax year. The voter-approval tax rate is the highest tax rate that City of La Feira may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of La Feria is proposing to increase property taxes for the 2024 tax year.
