An Ordinance of the City Commission of the City of Brownsville, Texas, to amend Chapter 86, "Streets, Sidewalks, and Certain other Public Places," to adopt Right-of-Way (ROW) management regulations, including provisions for closure of streets and encroachments, and amend the Master Fee Schedule to include said fees for the private use of the ROW, an encroachment licensing fee, and a fee for the private use of the ROW for special events. 03/04/2025
