Rio Bravo Pipeline Company, LLC Federal Energy Regulatory Commission Docket No. CP23-519-000

Notice is hereby given that on July 20, 2023, Rio Bravo Pipeline Company, LLC ("Rio Bravo") filed with the Federal Energy Regulatory Commission ("FERC") an abbreviated application for an amendment to the certificate of public convenience and necessity for the Rio Bravo Pipeline Project ("Project").

The Application seeks FERC's approval for Rio Bravo to make certain adjustments to the certificated pipeline route and to modify the pipeline design to use an alternative maximum allowable operating pressure ("Alternative MAOP"). Specifically, Rio Bravo is seeking approval for the following modifications: (i) to relocate the certificated pipeline route off Tract RBP-TX-WI-006 (formerly Tract NDWIL 001.50) and onto active agricultural lands located to the south to avoid and minimize impacts to potential ocelot habitat and other infrastructure between approximate MP 69.8 and MP 79.4 of the certificated pipeline route in Willacy County, Texas: (ii) to relocate the certificated pipeline route between approximate MP 92.4 and MP 93.0 in Willacy County, Texas to address agency requirements and landowner requests to relocate the crossing of the North Floodway: (iii) to relocate the certificated pipeline route between approximate MP 99.7 and MP 100.5 in Willacy and Cameron Counties, Texas to address landowner requests for the crossing of the Arroyo Colorado; (iv) a 0.6-mile extension of the pipeline route from the currently certificated terminus to a point within the fence line of the liquefied natural gas terminal to which the pipeline will interconnect and a related modification to the sites for horizontal directional drilling of the pipeline under wetlands adjacent to the terminal and new pipeline terminus; and (v) to modify the design of the proposed 48-inch and 42-inch mainline pipelines on a majority of the route located in Class 1 areas to use an Alternative MAOP, with the same maximum alternative operating pressure ("MAOP") and equivalent level of safety as the currently authorized Rio Bravo Pipeline Project but with modified pipe wall thickness and design factor pursuant to and consistent with regulations established by PHMSA.

Notice of the Application will be mailed to affected landowners and municipal, state, and federal governments and agencies involved in the Project. A copy of the Application and related resource reports are on file in the following public libraries and/or municipal and county offices.
