The bids will be publicly opened and read aloud immediately after 2:00 p.m. on Tuesday the **31<sup>st</sup> of October 2023** at Starr County Annex Building, 100 N. **The project will consist of the construction of Ranchito St. and reconstruction of Anacua St.**

Bids are invited for, but are not limited to, the items and approximate quantities as follows:

1. 4,113 SY of 11/2 in. of HMAc
2. 2,814 SY of 6 in. Subgrade & 8 in. Caliche Flex Base
3. 2,100 SY of 8 in. Reclaimed Asphalt & Caliche Base
4. 1,172 LF of 36 in. R.C.P
5. 1,696 LF of 12" x 18" Concrete Curb and Gutter

A bid bond in the amount of 5 percent of the bid issued by an acceptable surety is required with each bid for those contracts that exceed **\$25,000**. A certified check or bank draft payable to the County of Starr or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of age, race, color, religion, sex, sexual identity, gender identity, or national origin. Adherence to the grant recipient's Section 3 Policy is required for contracts and subcontracts in excess of \$100,000.00.

The County of Starr reserves the right to reject any or all bids or to waive any informalities in the bidding. Bids may be held by County of Starr for a period not to exceed 60 days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidders' qualifications prior to the contract award.
