Notice is hereby given that the Brownsville Community Improvement Corporation (BCIC), pursuant to the Texas Local Government Code Sec. 505.159, has conducted a 60-day comment period beginning November 1st 2024 to December 31, 2024 and will conduct a **PUBLIC HEARING** to consider the expenditure of Type B sales tax funds during a BCIC Board Meeting on **Thursday, March 27, 2025, at 4:00 P.M.** at the City Commission Chambers, located on the second floor of the Brownsville City Hall- Old Federal Building, Located at 1001 E Elizabeth St., Brownsville, Cameron County, Texas 78520.

The Public Hearing will be conducted to consider the request by the following applicants to expend Type B sales tax funds for the following quality of life project(s):

- Project #25-001Gorgas Science Foundation in the amount not to exceed One Hundred and Ninety-Five Thousand Seven Hundred Twenty-Seven Dollars and Zero Cents (\$195,727.00) to restore Sabal Palm Sanctuary buildings to improve public use, as well as enhance community health and wellness.
- Project #25-002 South Texas Astronomical Society in the amount not to exceed thirty thousand nine hundred and seventy-two dollars and thirtysix cents (\$30,972.36) to install a to-scale model of the Solar System to Brownsville's Linear Park.
- Project #25-003 Brownsville Tennis Center in the amount not to exceed three hundred and twenty thousand dollars and zero cents (\$320,000.00) for tennis center repairs, court lighting, and court resurfacing.
- Project #25-004 Children's Museum of Brownsville in the amount not to exceed seventy-three thousand eight hundred and forty dollars (\$73,840.00) for the installation of an awning.
- Project #25-005 West Brownsville Little League in the amount not to exceed one hundred eighty-nine thousand one hundred and two dollars and zero cents (\$189,102.00) for a shaded pavilion, park improvements such as light pole installation, ADA tables, as well as 20 trees.
- Project #25-006 Community Development Corporation of Brownsville in the amount not to exceed twenty thousand dollars and zero cents (\$20,000.00) to install a 253 sq. ft. Flexbox Module multipurpose room.
- Project #25-007 Tip-O-Tex Little Miss Kickball in the amount not to exceed two hundred and sixteen thousand dollars and zero cents (\$216,000.00) for purchasing and installing 4 scoreboards and 8 bleachers with shade.
- Project #25-008 Brownsville Society for Crippled Children Incorporated DBA Moody Clinic in the amount not to exceed twenty-eight thousand seven hundred and thirty-three dollars and sixty-nine cents (\$28,733.69) for the installation of a mural as well as the installation of lighting in the exterior.

Approved project(s) cannot begin, nor can any expenses be incurred, until the project agreement has been executed.
