The voter-approval rate is the highest tax rate that EMERGENCY SERVICE DISTRICT #1 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that EMERGENCY SERVICE DISTRICT #1 is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 27, 2025 AT 1:30 PM AT EMERGENCY SERVICES DISTRICT, 2ND FLOOR 964 E HARRISON STREET, BROWNSVILLE, TX 78520. (EOC-ADMIN BUILDING 2ND FLOOR).

The proposed tax rate is not greater than the voter-approval tax rate.
