The City of Harlingen's Community Development Department is requesting sealed proposals for our **CONTRACTORS VENDOR POOL FOR RESIDENTIAL HOME REPAIRS** as part of the following programs:

- Housing Rehabilitation Program (funded by the U.S. Department of Housing and Urban Development through the Community Development Block Grant Program)
- Healthy Homes Program (funded by the U.S. Department of Housing and Urban Development through the Office of Lead Hazard Control and Healthy Homes) and
- Housing for Texas Heroes Program (funded by the Texas Veterans Commission)

This is a qualification-based solicitation. Pricing is not submitted as a part of this evaluation process for submitted qualification proposals. Interested parties shall submit two (2) complete proposal packages with all of the required documents to the Community Development Department located at 502 E. Tyler, Harlingen, Texas 78550 before the RFQ due date and time of 2:00 PM, FRIDAY, NOVEMBER 21,

2025. Sealed qualification packages will then be publicly opened by the Community Development Department staff at the City of Harlingen, Texas at 2:30 pm at the Lon C. Hill Conference Room.

SCOPE OF WORK: The City of Harlingen is seeking to engage qualified Proposers

to provide Contractor Services for Residential Home Repair programs that include the Housing Rehabilitation Program, Healthy Homes Program, and the Housing for Texas Heroes Program which are administered by the City of Harlingen's Community Development Department in full accordance with the scope of services, terms, and conditions contained in the documents of the Request for Qualifications (RFQ).

The City intends to establish a pool of qualified and experienced contractors to complete various types of home repairs of residential homes such as accessibility modifications,

weatherization services, flooring, roof repairs, driveways, foundations, caulking, siding, ramps, windows, doors, painting, rodent infestation, electrical issues, plumbing, HVAC systems, ceilings, walls and other deficiencies based on eligibility under the specific program being utilized. The established list of pre-qualified contractors will be eligible

to bid on residential property rehabilitation work identified by the City's Community Development Department. Any vendor who wishes to be part of the pool of contractors must submit a response to this solicitation for furnishing the services.
