

ADVERTISEMENT AND INVITATION FOR BIDS

The City of Primera, Texas will receive bids for "CITY OF PRIMERA FIRST TIME SEWER IMPROVEMENTS GLO CONTRACT NO. 24-067-037-E225" project. **Bids must be delivered to the Primera City Hall, 17635 Primera Road, Primera, TX 78552 on or before 2:00 P.M. on Thursday, February 5, 2026, at which time all bids will be publicly opened and read aloud.**

The project consists of proposed improvements at various locations, improvements include installation of 8" PVC SDR-26 sanitary sewer line, 4" PVC sanitary sewer line, new manholes, decommissioning of existing septic tanks, installation of clean-outs, removing and replacing approximately 18" RCP, and related appurtenances as shown on the Plans and required by the Specifications in Primera, Texas.

A bid bond in the amount of 5 percent of the bid issued by an acceptable surety shall be submitted with each bid [for those contracts that exceed \$100,000]. A certified check or bank draft payable to the City of Primera or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond.

Bid and Contract documents, including Drawings and Technical Specifications are on file at the City of Primera, City Hall, 17635 Primera Road, Primera, TX 78552. **A pre-bid conference will be held on Wednesday, January 28, 2026 at 10:00 A.M. at the Primera City Hall, 17635 Primera Road, Primera, TX 78552. Be advised that the pre-bid conference is not mandatory.**

The project to be constructed will be financed with assistance from the General Land Office (GLO) under the U.S. Department of Housing and Urban Development Community Development Block Grant - (CDBG) program and is subject to all applicable Federal and State laws and regulations. Attention is called to the fact that not less than, the federally determined prevailing Davis-Bacon and Related Acts wage rate, as issued by the Department of Labor and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual orientation, gender identity, or national origin. Adherence to the City of Primera 3 Policy is required for all contracts.

All contractors and subcontractors must be cleared (not suspended or debarred) prior to any formal action authorizing the award of a contract to the contractor. Minority Business Enterprises, Small Business Enterprises, Women Business Enterprises, Veteran-Owned Businesses, Section 3 Businesses, and labor surplus area firms are encouraged to submit bids.

The City of Primera reserves the right to reject any or all bids or to waive any informalities in the bidding. Bids may be held by City of Primera for a period not to exceed 60 days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidder's qualifications prior to the contract award.
