All bids must be in the City of Elsa's possession on or before the aforementioned date and time (no late bids will be accepted). City of Elsa's normal business working days are Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. and closed on Saturdays, Sundays and City recognized holidays.

## CITY OF ELSA FANNIN ST. ROADWAY IMPROVEMENTS

*This project consists of milling and overlaying Fannin Street located in the intersection of E. Edinburg Ave. (FM 107) and S Fannin St., Elsa, Texas.*

A Bidder's Bond from a reliable surety company licensed to operate in the State of Texas or certified Cashier's check without payable recourse to the City of Elsa, for the amount of not less than five (5) percent (%) of the total bid shall accompany the bid as a guaranty that, if awarded the contract, the bidder will enter into a contract with the City of Elsa within the time specified. Payment and Performance Bonds shall be executed except in the event that the total amount bid is \$50,000 or less, the successful contractor has the option to enter into a single payment contract within the City of Elsa in lieu of a Payment and Performance bond. Failure to execute contracts with the specified time shall forfeit to the Owner, as liquidated damages for such failure or refusal, the security (bid bond) deposited with his bid.
